MCVMA Secures Permanent Open Access to First DEI Publications in Veterinary Medicine

[Silverdale, WA] — The Multicultural Veterinary Medical Association (MCVMA) is proud to announce the permanent open access availability of the first comprehensive publications dedicated to diversity, equity, and inclusion (DEI) in veterinary medicine. These groundbreaking collections, "Veterinary Clinics: Small Animal Practice – Diversity, Equity, and Inclusion in Veterinary Medicine," Parts 1 and 2, were published by Elsevier and are now freely accessible to the public thanks to support from Maddie's Fund®, a national family foundation established by Dave and Cheryl Duffield to revolutionize the status and well-being of companion animals.

Edited by MCVMA Past President and Founding Dean of Hanover College School of Veterinary Medicine Christina V. Tran, DVM, the two-part series features 20 review articles and editorials authored by a diverse group of experts, including veterinarians, veterinary technicians, social workers, and educators. Among the list of contributors are nationally recognized leaders Dr. Michael Blackwell, Dr. Vernard Hodges, Dr. Coretta Patterson, Dr. Katherine Fogelberg, and Veterinary Technician Specialist Stephen Niño Cital.


A Historic Milestone in Veterinary Literature


These publications represent the first scholarly collections dedicated solely to DEI in veterinary medicine—an essential step in addressing the systemic inequities affecting both professionals and clients within the field.

In **June 2025**, MCVMA purchased **permanent open access** to both volumes, making every article in the series **freely available to read, download, cite, and share without restriction**. This effort ensures continued accessibility to these vital works for current and future generations of veterinary professionals, educators, and students, regardless of income or institutional affiliation.

"We can't stress enough how grateful we are to Maddie's Fund and Issue Editor Dr. Tran for making this possible," said **Melody Martínez, CVT**, MCVMA Executive Director and contributing author. "Without their support and continued advocacy, these authors' contributions would have remained behind a paywall, only accessible to those with the means to pay or who otherwise have institutional access."

"In our current political and economic climate, MCVMA believes that open access to DEI information and educational tools is imperative to counter the ongoing misinformation and attacks on equity and justice," Martínez continued. "This initiative will increase the visibility and impact of the research, and has the potential to accelerate more studies and generate stronger policy solutions to address inequities in the veterinary profession."
